the Board of Directors of NEW MILLENNIUM SICAV (hereafter the "Company") takes pleasure in presenting its annual report together with the annual accounts of the Company for its first financial year ended on 31 December 2021.

1. CORPORATE GOVERNANCE

The Company

The Company is a Luxembourg investment company (Société d'investissement à capital variable) incorporated for an unlimited duration in Luxembourg on 11 August 1999 and organised under Part I of the Luxembourg Law of 17 December 2010 on undertakings for collective investment (the "Law of 17 December 2010") and the Law of 10 August 1915 on commercial companies, as further amended and supplemented.

The Company was initially qualified as a self-managed investment company within the meaning of art. 27 of the Law of 17 December 2010; effective from 1 January 2017 the Company has designated Natam Management Company S.A. (NATAM), a management company governed by Chapter 15 of the Law of 17 December 2010 and authorised pursuant to the UCITS Directive.

The rules of conduct

In performing its activity NATAM complies, at all times, with the rules of conduct set in the Law of 17 December 2010 such as: to act honestly and fairly in conducting its business activities in the best interest of the clients and the integrity of the market; to act with due skill, care and diligence, to have and efficiently employ resources and procedures that are necessary for the proper performance of the business activities; to try to avoid conflict of interest and when they cannot be avoided, to ensure that the clients are fairly treated and to comply with all the regulatory requirements.

In addition NATAM, as part of the Banca Finnat Group, has adopted the Banca Finnat Ethical Code, which applies to all directors, employees and collaborators of the group and it has also adopted the ALFI Code of Conduct, to set a framework of high-level principles and best practice recommendations for the governance of the Company.

The Board of Directors' composition

The annual general meeting of the Company, held on 21 April 2021, has re-elected the 3 board members (Mr. Jannoni, chairman, Mr. Mauceri and Mr. Bonabello) until the following general meeting of shareholders to be held in 2022.

The Board of Directors remuneration

Each director is paid a fixed annual remuneration respecting the maximum threshold of 25.000 Euro. The remuneration, which reflects responsibilities and experience and is fair given the size and complexity of the Company has been approved by the shareholders at the Annual General Meeting of shareholders.

Board of Directors meetings

The Board of Directors meets at least two times a year. Additional meetings are arranged if necessary.

In 2021, three regular Board meetings were held. At the regular Board meetings, NATAM reports on various relevant topics, amongst others, financial and operational risks, investment compliance monitoring, valuation issues, marketing and sales activities, anti-money laundering matters and regulatory update.

Annual General Meeting

The Annual General Meeting of the shareholders (AGM) was been duly held on 21st April 2021 in Luxembourg. During the meeting, the shareholders; i) have approved the management report of the Board of Directors and the report of the auditor for the financial year ended as per 31 December 2020; ii) have approved the audited statements of assets and liabilities and the statement of operations for the financial year ended as per 31 December 2020; iii) have approved the allocation of the net results for the financial year ended as per 31 December 2020; iv) have ratified the decision taken by the Board of Directors until the AGM held in 2021 and have granted full discharge to the members of the Board of Directors with respect to their performance of duties for all or part of the financial year ended as per 31 December 2020; v) have re-elected the directors and set their remuneration, as mentioned above; vi) have re-elect the auditor, PricewaterhouseCoopers, to serve for the financial year 2021.

2. SIGNIFICANT EVENTS OCCURRED DURING THE FINANCIAL YEAR

Prospectus:

During the year 2021 the Prospectus has been updated on March 2021

- to add the disclosure requirements of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector (in particular a description of the "Sustainability Risk" has been added as far as the "Disclosure on ESG integration practices" according to the Art. 6 and Art. 8).
- to increase of the expected leverege of the Sub-funds Augustum High Quality Bond Augustum Corporate Bond, Augustum Italian Diversified Bond, Augustum Market Timing, Augustum Extra Euro High Quality Bond, Evergreen Global and High Yield Bond

In addition, on 29th November 2021, the SICAV has filled the CSSF to introduce some other amendments to the Prospectus such as 1) the introduction of the high water mark principle, for the sub fund named "Multi Asset Opportunity"; 2) the introduction of performance fees calculation example for the following sub funds (Augustum Corporate Bond, Augustum High Quality Bond, Augustum Italian Diversified Bond, Augustum Extra Euro High Quality Bond, Evergreen Global High Yield Bond, Augustum Market Timing) and 3) to add some transparency disclosures, related to the Regulation (EU) 2020/852 of 18 June 2020.

3. SUB-FUNDS' PERFORMANCE

Investments Manager: Banca Finnat Euramerica S.p.A.

NEW MILLENNIUM - Balance World Conservative

The sub-fund closed the year with an absolute performance of +1,96% (Class I) even if with a gap of -232 bps from the benchmark. The portfolio, while managing to close with a positive performance, suffered the bad year on the asset class to which it was exposed (Convertibles, Chinese equities) which generated the gap against the benchmark. On the other hand, the bet on the dollar, of which it was weighed for the whole year, was positive. The performance of the HY was also good. The average annual rating of the bond component was BBB with an average duration of 3.6.

The sub-fund closed the year with an absolute performance of +18,26% (Class I) while the performance of the benchmark was + 22.50%. The selection model, in which greater diversification towards non-ultra big caps prevails, was not rewarding during the whole year. The overall average equity exposure over the year remained in line with that of the benchmark, as well as the weights of the sectors.

NEW MILLENNIUM - Euro Bond Short Term

The sub-fund closed the year with an absolute negative performance of -0.69% (Class I) 6 bps worse than the benchmark. It was not a favorable year for the fixed-rate bond market with the BTP-Bund spread which rose in the last quarter closing the year at 130 compared to 110 the previous year. The sub-fund had a low duration between 1.5 and 1.8, through a positioning mainly on short sections of both "core" and "peripheral" European government curves and exposure on 2-4 year maturities on corporate securities.

NEW MILLENNIUM - Global Equities (Eur Hedged)

The sub-fund closed the year with an absolute performance of +19,70% (Class I), against a benchmark that recorded growth of + 22.07%. The main world indices in the year tested new all-time highs with unexpected speed and intensity. Equity exposure was in line with the reference index, with the exception of the second half of the year. During this period, risk appetite was revised significantly downwards. The slight underweight in equities and the lower exposure to the non-ultra big caps of the list generated the relative underperformance. The average equity exposure in the year was around 95%, with constant coverage of the exchange rate risk.

NEW MILLENNIUM - Inflation Linked Bond

The sub-fund closed the year with an absolute performance of +3,84% (Class I) even if underperforming the benchmark of 42bps. A positive year for the inflation-linked securities market thanks to the sharp rise in inflation expectations and the surge in commodity prices. During the year, the portfolio choices were oriented on the 3-5 year and 7-10 year curve sections; while in the last weeks of the year we significantly reduced the positions on the long section 15-20 maintaining an average duration slightly higher than 2. During the year we had exposure to commodities in the range between 2% and 5%.

NEW MILLENNIUM - Large Europe Corporate

The sub-fund closed the year with an absolute performance of -0,92% (Class I), 81 bps behind its benchmark. 2021 was still affected by the pandemic, despite the fact that this conditioning took place in a different way from the previous year. The growth recorded this year led to a new economic push that created evident inflationary pressures. The market has been betting throughout the year on the fact that Central Banks would react to this situation even though the latter continued to assert until the end of the year that inflation would be transitory. The portfolio was positioned on an average rating of BBB / BBB + and the duration remained on average values of 3 / 3.1 throughout the year.

NEW MILLENNIUM - PIR Bilanciato Sistema Italia

The sub-fund closed the year with an absolute performance of +8,54% (Class I) gaining +52 bps compared to the benchmark. The excellent result of the sector was favored by an Italian market which throughout the year benefited from considerable interest from investors who wanted to reward a general Italian situation that is highlighting a newfound credibility also in the international arena. The sub-fund maintained an average equity weight always very close to 40% with a presence of Mid and Small Caps which reached a weight of up to 25%. The average duration was around 3.7.



Investments Manager: Az Swiss & Partners S.A.

NEW MILLENNIUM - Augustum Corporate Bond

The sub-fund closed the year with a NAV of 249.58 and a performance of 2.74% (Class I).

The initial months of 2021 were forecasted by a favorable forecast of expansionary policies (monetary and fiscal) and economic recovery. Equity and credit markets reported positive performance, but uncertainties about Covid-19 and delays in vaccination process variants caused significant volatility. The manager used very attractive levels of credit spreads (at their lows since the start of the pandemic) to build a credit risk hedging position using the iTraxx Crossover Index.

Already in the first part of the year the hypothesis emerged that the strongly expansionary measures could cause an overheating of the economy and an increase in the increase. This caused volatility in the rate market, despite the period's abandonment data remaining subdued. Central banks have maintained expansionary monetary policies.

Monthly inflation surveys began to show an increasing trend starting from April. The tone of the central banks has changed, recognizing in the following months the possibility of an inflationary phenomenon, albeit temporary. In hypothesizing reductions in huge monetary stimuli (so-called tapering), the Governor Powell of the Fed strongly emphasized the gradualness of the process: the fear of compromising the recovery continued to prevail over that of out-of-control inflation. Meanwhile, increasingly encouraging economic data have given impetus to the equity and credit markets, which have reported good performance during the central months of the year, as has the sub-fund.

Since September there has been a correction on the equity and credit markets. The bottlenecks in international logistics systems and a marked rise in the prices of energy raw materials (oil, natural gas) have cast shadows on economic growth, supporting the hypothesis that inflation would not have been a transitory phenomenon. Central banks have begun to be more concerned: the ECB has announced a reduction in monthly purchases of the PEPP (while confirming the desire to maintain an expansionary monetary policy) and the FED has declared the beginning of the reduction of monetary stimuli (so-called tapering). At this stage, the investor manager continued to dynamically manage, in spreads, the credit risk of the most speculative component of the sector, through hedging positions on the iTraxx Crossover index, in order to limit its volatility.

At the end of November, the spread of the Omicron variant of Covid-19 caused a flare-up of volatility. Equity markets reported significant losses, as did corporate bonds in the Non-Investment-Grade segment: cyclical and recovery-related sectors were the hardest hit. Over the next month, news of the variant likely to be less dangerous triggered a rebound on equity and credit markets. The investor manager took advantage of the November volatility window to reduce hedging on the iTraxx Crossover index, taking advantage of the December rebound.

NEW MILLENNIUM - Evergreen Global High Yield Bond

The sub-fund closed the year with a NAV of 94.37 and a performance of 8.36% (Class I).

The initial months of 2021 were characterized by a favorable conjuncture of expansionary policies (monetary and fiscal) and expectations of economic recovery. The equity and credit markets performed well, but the uncertainties surrounding Covid-19 variants and delays in vaccination processes caused significant volatility. The manager took advantage of the very attractive levels of credit spreads (at their lowest since the start of the pandemic) to build a credit risk hedging position using the iTraxx Crossover index.

Already in this first part of the year, the hypothesis was made that the strongly expansionary measures could have caused an overheating of the economy and an increase in inflation. This caused volatility in the interest rate market, despite the fact that inflation data for the period remained contained. Central banks have maintained expansionary monetary policies.

Monthly inflation surveys began to show an increasing trend starting from April. The tone of the central banks has changed, recognizing in the following months the possibility of an inflationary phenomenon, albeit temporary. In hypothesizing reductions in huge monetary stimuli (so-called tapering), the Governor Powell of the Fed strongly emphasized the gradualness of the process: the fear of compromising the recovery continued to prevail over that of out-of-control inflation. Meanwhile, increasingly encouraging economic data have given impetus to the equity and credit markets, which have reported good performance during the central months of the year, as has the sub-fund.

Since September there has been a correction on the equity and credit markets. During the following month, news of the variant likely to be less dangerous triggered a rebound on equity and credit markets. The manager took advantage of the November volatility window to reduce hedging on the iTraxx Crossover index, allowing the fund to fully capture the December rebound.

NEW MILLENNIUM - Augustum Extra Euro High Quality Bond

The sub-fund closed the year with a NAV of 112.15 and a performance of 4.88% (Class I).

The initial months of 2021 were characterized by a favorable conjuncture of expansionary policies (monetary and fiscal) and expectations of economic recovery. Markets reported positive performance, but uncertainties about Covid-19 variants and delays in vaccination processes caused significant volatility. Already in this first part of the year, the hypothesis was made that the strongly expansionary measures could have caused an overheating of the economy and an increase in inflation. This resulted in volatility on the interest rate market, despite the fact that inflation data for the period remained contained and central banks maintained expansionary monetary policies. The manager increased US dollar exposure, given inflation expectations in the United States and the Fed's greater sensitivity (compared to the ECB) to these issues.

Monthly inflation surveys began to show an increasing trend starting from April. The tone of the central banks has changed, recognizing in the following months the possibility of an inflationary phenomenon, albeit temporary. In hypothesizing reductions in huge monetary stimuli (so-called tapering), the Governor Powell of the Fed strongly emphasized the gradualness of the process: the fear of compromising the recovery continued to prevail over that of out-of-control inflation. The interest rate market continued to be affected by repeated episodes of volatility, especially at the meetings of the main central banks. The US dollar appreciated markedly against the Euro during the period, rewarding the fund's overexposure to the currency.

Starting from September, there has been a correction in the equity and credit markets. The bottlenecks in international logistics systems and a marked rise in the prices of energy raw materials (oil, natural gas) have cast shadows on economic growth, supporting the hypothesis that inflation would not have been a transitory phenomenon. Central banks have begun to be more concerned: the ECB has announced a reduction in monthly purchases of the PEPP (while confirming the desire to maintain an expansionary monetary policy) and the FED has declared the beginning of the reduction of monetary stimulus (so-called tapering), fueling the volatility in the interest rate market and causing a strengthening of the dollar. The investor manager has partially reduced the exposure to the dollar, taking profit and bringing the exposure back to the levels of the beginning of the year.

At the end of November, the spread of the Omicron variant of Covid-19 led to an increase in volatility. Equity markets reported significant losses, as did corporate bonds: cyclical and recovery-related sectors were the hardest hit. During the following month, the news on a probable lower danger of the variant favored a rebound in the markets.

NEW MILLENNIUM - Augustum High Quality Bond

The sub-fund closed the year with a NAV of 163.42 and a performance of 2.46% (Class I).

The initial months of 2021 were characterized by a favorable conjuncture of expansionary policies (monetary and fiscal) and expectations of economic recovery. Markets reported positive performance, but uncertainties about Covid-19 variants and delays in vaccination processes caused significant volatility. Already in this first part of the year, the hypothesis was made that the strongly expansionary measures could have caused an overheating of the economy and an increase in inflation. This resulted in volatility on the interest rate market, despite the fact that inflation data for the period remained contained and central banks maintained expansionary monetary policies. The investor manager took short positions on the long part of the European curve, taking advantage of the steepening movements of the European curves, managing hedges dynamically to limit the sub-fund volatility compared to the sector.

Monthly inflation surveys began to show an increasing trend starting from April. The tone of the central banks has changed, recognizing in the following months the possibility of an inflationary phenomenon, albeit temporary. In hypothesizing reductions in huge monetary stimuli (so-called tapering), the Governor Powell of the Fed strongly emphasized the gradualness of the process: the fear of compromising the recovery continued to prevail over that of out-of-control inflation. The interest rate market continued to be affected by repeated episodes of volatility, especially at the meetings of the main central banks.

Starting from September, there has been a correction in the equity and credit markets. The bottlenecks in international logistics systems and a marked rise in the prices of energy raw materials (oil, natural gas) have cast shadows on economic growth, supporting the hypothesis that inflation would not have been a transitory phenomenon. Central banks have begun to be more concerned: the ECB has announced a reduction in monthly purchases of the PEPP (while confirming the desire to maintain an expansionary monetary policy) and the FED has declared the beginning of the reduction of monetary stimuli (so-called tapering), fueling volatility in the interest rate market. The manager continued to dynamically manage the duration of the fund, as it did throughout the year, in order to keep volatility at low levels and profit from market movements.

At the end of November, the spread of the Omicron variant of Covid-19 led to an increase in volatility. Equity markets reported significant losses, as did corporate bonds: cyclical and recovery-related sectors were the hardest hit. During the following month, the news on a probable lower danger of the variant favored a rebound in the markets. The dynamic management of the duration has allowed the sub-fund to report significantly better performance than the benchmark even during the last part of the year.

NEW MILLENNIUM - Augustum Italian Diversified Bond

The sub-fund closed the year with a NAV of 146.85 and a performance of 3.42% (Class I).

The initial months of 2021 were characterized by a favorable conjuncture of expansionary policies (monetary and fiscal) and expectations of economic recovery. The installation of a new high-profile government led by former ECB president Mario Draghi, who is strongly pro-European, has contributed to reducing the credit risk of Italian issues.

NEW MILLENNIUM - Multi Asset Opportunity

The sub-fund closed the year with an absolute performance of +5.79% (Class I).

After the great correction of March 2020, the main world lists also grew during 2021 with few setbacks. Central bank policy remained expansive. Many governments have put in place ambitious investment plans to revive the post-pandemic economy. In the United States they called it Green New Deal, the European counterpart was the Next Generation Eu, whose funds in our country will be spent through the National Recovery and Resilience Plan (or Pnrr).

From the point of view of the bond market, negative rates in Europe and strong purchases by Central Banks led to a negative result for the majority of bond yields in 2021. The High Yield sector, less sensitive to interest rate movements and more linked to the risk of credit continued to benefit from ongoing robust growth. The preferred type of securities were government bonds with short duration and inflation-related yields, subordinated bonds of both financial and corporate issuers and HY bonds with BB ratings. The duration of the bond portfolio tended to be lower than that of the reference benchmark.



During the year there was a surge in the price of raw materials (aluminum grew by 42.2%, steel by 22.3% while nickel by 26.1%) and the crisis of semiconductors, essential for automotive and the production of many electronic devices. But it was also observed the sharp increase in the costs of energy supply, with the very high prices of coal and natural gas. The price of oil also rose, with Brent at \$ 77.78 a barrel and WTI at \$ 75.21, while a year earlier they were both below \$ 55. All this has led to a rise in global inflation which has transformed from a transitory phenomenon into a more persistent scenario, forcing central banks to re-evaluate their accommodative monetary policies in order to counter the possible negative effects of inflation above of the respective targets.

With regard to the equity sector, the Sub-fund was on average overexposed to equity compared to the benchmark, benefiting from the performance of the main global equity indices. America, in particular, had a year on the shields, with the S & P 500 which increased its value by more than 25% (more than 35% in Euros). A sentiment that was widely shared by Europe, where the Eurostoxx50 recorded more than 20% upside.

Investments Manager: Diaman Partners Ltd

NEW MILLENNIUM - VolActive

The sub-fund closed the year with a NAV of 110.93 and a performance of 4.80% (Class I).

The bond component maintained a duration slightly over 3 years in order to generate a slightly positive Yield To Maturity. The Asset Allocation was made up on average of about 55% in Government bonds, 30% in Corporate bonds and 8% in Euro Equity. 92% of the selected bonds are Investment Grade. In 2021 the Vix index went from 22.75 to 17.22 benefiting from the worldwide vaccination campaign but recording a couple of spikes above 30 as soon as news of new variants of the virus was learned. The models performed well over the course of the year. Both during the low volatility phase, where the market contango was well exploited, and during the spikes, positioning itself Neutral. Only at the end of November did the model indicate that it would expose itself Long, closing the position nine days later essentially at par.

Over the course of the year, models were positioned 87% of the time short-term, 3% long, and 10% neutral.

Our opinion

NOTES TO THE FINANCIAL STATEMENTS

1. GENERAL INFORMATION

NEW MILLENNIUM, referred to hereafter as the "Fund", is a Luxembourg investment company (Société d'investissement à capital variable) incorporated for an unlimited duration in Luxembourg on 11 August 1999 and organised under Part I of the Luxembourg Law of 17 December 2010 on undertakings for collective investment (the "Law of 17 December 2010"), as amended, and the Law of 10 August 1915 on commercial companies as amended on 10 December 2010.

The Fund is composed of different Sub-Funds, each one with its own assets and managed according to a specified investment policy.

Effective from the 1st of January 2017 the Fund has appointed Natam Management Company S.A. as Management Company of the fund.

The Fund's aim is to offer its shareholders easy access to various transferable securities whilst adhering to the principle of risk spreading. Nearly all transferable securities purchased are listed on an official stock exchange or traded on a regulated market that operates regularly and is recognised and open to the public.

2. SUMMARY OF MAIN ACCOUNTING POLICIES

The Fund keeps the books of each Sub-Fund in its respective currency and the financial statements were prepared in EUR in accordance with the Luxembourg regulations relating to undertakings for collective investment and in particular using the following valuation rules:

a) Valuation of investment securities

Investment securities, including zero-coupon bonds and money market instruments, quoted on an official stock exchange or on another regulated market are valued according to the last known price and, in the event of being quoted on several markets, according to the last known price of the principal market.

Valuation of investment securities, including zero-coupon bonds and money market instruments, not quoted on an official stock exchange or on another regulated market is fixed in a reasonable way on the basis of the sale prices anticipated cautiously, determined prudently and in good faith.

The value of each investment in open-ended funds, either listed or not, is based on the last known Net Asset Value on the Valuation Day.

In the absence of an active market for financial instruments, then the valuation will be made by reference to alternative methods such as approaching a broker for a quote, or applying any other ad hoc analysis judged relevant by the Management Company.

b) Net realised profit (loss) on sale of investments

Realised profits or losses made on the sales of investments are calculated according to the average cost.

c) Forward foreign exchange contracts

Forward foreign exchange contracts are valued at forward foreign exchange rate for the remaining period to run until maturity at the date of valuation.

Unrealised profits and losses are recorded in the Statement of Net Assets and their variations recorded in the Statement of Operations and Changes in Net Assets under the heading «Change in unrealised appreciation / (depreciation) on forward foreign exchange contracts».

d) Futures contracts

Commitments related to futures contracts are recorded off balance sheet and futures contracts are valued according to the last available contract price. Unrealised profits and losses on futures contracts are recorded in the Statement of Net Assets and their variations recorded in the Statement of Operations and Changes in Net Assets under the heading «Change in unrealised appreciation / (depreciation) on futures contracts». Guarantee deposits are booked under the heading «Amounts due from brokers» and «Amounts due to brokers».

e) Option contracts

Options quoted on an official stock exchange or on another regulated market are valued according to the last known market price or, if there are several markets, according to the last known price of the principal market.

Options not quoted on an official stock exchange or on another regulated market are valued at their last known market value or, in the absence of a market value, according to their probable market value in the reasonable estimation of the Board of Directors of the Fund.

Premiums received on the writing of option contracts are recorded as liabilities and premiums paid on purchased of option contracts are recorded as assets. Unrealised gains and losses are recorded in the Statement of Net Assets and their variations in the Statement of Operations and Changes in Net Assets under the heading «Change in unrealised appreciation / (depreciation) on option contracts».

f) Swap contracts

Swaps are valued at their fair value based on the underlying securities as well as on the characteristics of the underlying commitments or otherwise in accordance with usual accounting practices.

Upfront payments, which represent a risk premium of Credit Default Swaps, are recorded in the Statement of Net Assets under the heading "swap premium received". This payable amount is related to the amount of cash received to compensate the difference between the market value of the Credit Default Swaps and the entry proceeds.

The market value of Credit Default Swaps is calculated as the sum of the swap premium received and the unrealized profit/(loss) recorded in the Swap Contracts section.

g) Cost of purchase of securities in portfolios

For securities in currencies other than the base currency of the Sub-Fund, the purchase price is calculated according to the closing exchange rate on the day of purchase.

h) Income

Dividends are recognised on the date on which the Shares/Units concerned are quoted «exdividend», net of withholding tax. Interest is calculated on a prorata temporis basis, net of withholding tax.

i) Translation of items expressed in foreign currencies

Assets and liabilities in foreign currencies are converted into the base currency of the Sub-Fund at the closing exchange rate on the final day of the financial year.

Income and expenses in currencies other than the base currency of the Sub-Fund are converted into the currency of the Sub-Fund at the closing exchange rate in force on the day of the transaction.

Any resulting gain or loss made on foreign exchange is included in the Statement of Operations and Changes in Net Assets.

j) Net Asset Value per Share

The Net Asset Value of each Sub-Fund is equal to the difference between the total assets and the liabilities of the Sub-Fund.

The Net Asset Value per Share is calculated by dividing the net asset value by the number of Shares outstanding on the day of calculation.

k) Presentation of the Financial Statements

The financial statements are presented on the basis of the last Net Asset Value (NAV) of the year. In accordance with the prospectus, the NAVs have been calculated on the basis of the last market price available at the time the calculation was performed.

m) Cross-Investments

The combined financial statements show a total net asset value of EUR 1,058,162,682.89. At the end of the year, the Sub-Funds NEW MILLENNIUM - Augustum Market Timing and NEW MILLENNIUM - Balanced World Conservative invested a total amount of EUR 2,063,490.21 in other Sub-Funds of the umbrella NEW MILLENNIUM. If those investments are excluded from the combined financial statements, the total net asset value for the Fund would be EUR 1,056,099,192.68.

3. TAXATION

The Fund is governed by Luxembourg tax laws applicable to investment funds.

As legislation now stands, the Fund is subject to a Luxembourg subscription tax at an annual rate of 0,05% calculated and payable quarterly on the Net Asset Value of each Sub-Fund at the end of each quarter in question.

The rate of the annual subscription tax is fixed at 0,01% for the Sub-Funds or Classes of Shares, if the Shares in these Sub-Funds or Classes are reserved for one or more Institutional Investors, as well as for Sub-Funds whose exclusive aim is the collective investment in money market instruments and/or deposits with credit institutions.

The value of the assets represented by Shares held in other UCIs shall be exempt from the subscription tax, provided such UCIs have already been subject to the subscription tax.

4. OTHER CHARGES AND TAXES

Registration fees payable to the Authority of Control and other professional fees (domiciliary, distribution, paying administrator and miscellaneous) are divided amongst the various Sub-Funds in proportion to the Net Asset Value of each Sub-Fund.

In each Sub-Fund of the Fund, this fee is payable quarterly and calculated on the basis of the average Net Asset Value during the relevant quarter.

The Management Company is also entitled to receive from each Sub-Fund a fixed fee up to EUR 11,000.00 payable on a quarterly basis in arrears.

Besides this, the Sub-Fund NEW MILLENNIUM - Augustum Market Timing pays a distribution fee at an annual rate of 1% on the Share classes A and D. This fee is payable quarterly to the Distributors and calculated and accrued on a daily basis with reference to the Net Asset Value.

In addition as at 31 December 2021, the Sub-Fund NEW MILLENNIUM - Augustum Market Timing is investing more than 50% in UCI Shares. In respect of a Sub-fund's substantial investments in UCITS and other UCIs linked to the Fund, or other sub-funds within the SICAV, the total management fee (excluding any performance fee, if any) charged to such Sub-Fund and each of the UCITS or other UCIs concerned shall not

exceed 2% of the relevant net assets under management. The percentage of management fees charged at the level of these UCI Shares are the following:

The performance fee will be based on the difference, if positive, between the last computed GAV (Gross Asset Value or net asset value per share before deduction of performance fees) as at the end of a 12 month period, starting the 1 January of each year, and the highest net asset value per share calculated as at the end of any preceding period and giving rise to the payment of a performance fee, since the first period, or the first net asset value of the first period subject to a performance fee calculation. The performance fee shall be a percentage, indicated below, of the difference so determined multiplied by the number of shares in circulation of the Sub-Fund.

The Fund will apply at all times the High Water Mark Principle, i.e. no performance fee shall be paid in the case where the Gross Asset Value (the "GAV") which is the Net asset value per share after deducting all fees and liabilities and the management fee (but not the performance fee) as at the end of the reference period is lower than the highest Net asset value per share calculated as at the end of any preceding period and giving rise to the payment of a performance fee since the first period, or the first Net asset value per share of the first period in which a performance fee was calculated ("High-Water Mark"). The reference period shall start on the 1st January of each year and end on the 31st December.

The performances of the Shares are calculated considering the reinvestment of dividends, if any. The performance fee shall be a percentage, indicated below, of the excess return over the relevant benchmark below.

The performance fee is applied to the smallest value between the total net assets of the Sub-Fund at the calculation day and the average total net Assets of the Sub-Fund during the reference period. The reference period shall start on the 1st January of each year and end on the 31st December of the same year. The performance fees are submitted to the occurrence of the following conditions:

- GAV of the Sub-Fund is above HWM
- In the reference period the performance of the Sub-Fund is positive and higher than the performance of the benchmark.

Once verified the above two conditions, a double scenario can raise:

a) HWM is equal or higher than the NAV as at the end of the previous year: the accrual will be calculated on the difference between the performance of the Sub-Fund and the performance of the benchmark starting on the date the HWM has been beaten. The performance fee shall be a percentage, indicated below, of the excess return over the relevant benchmark below.

The performance fee is applied to the smallest value between the total net assets of the Sub-Fund at the calculation day and the average total net Assets of the Sub-Fund during the reference period. The reference period shall start on the 1st January of each year and end on the 31st December of the same year. The performance fees are submitted to the occurrence of the following conditions:

- In the reference period the performance of the Sub-Fund is positive and higher than the performance of the benchmark.
- Once verified the above condition, the accrual will be calculated on the difference between the performance of the Sub-Fund and the performance of the benchmark over the reference period.

Much of the international community has responded by imposing economic sanctions on Russian persons (individuals and entities). Financial markets have experienced and may continue to experience significant volatility. Securities issued by Russian entities or denominated in rubles have experienced a drastic decline in value, as well as trading restrictions. The Funds managed have a very low exposure to these securities, the impact has been therefore non-material. The Company put in place through the activity of NATAM and its delegates, the appropriate measure to ensure the risk monitoring, sanction and anti-money laundering.

2. REMUNERATION POLICY

2.1 Board of Directors of NEW MILLENNIUM SICAV (the "SICAV")

The members of the Board of Directors of the SICAV are reimbursed their out-of-pocket expenses and are entitled to receive an annual remuneration (payable on a semiannual basis on arrear), as set by the Annual General Meeting of Shareholders. The Annual General Meeting of Shareholders of the SICAV, held on 21 April 2021, for the exercise 2021, approved a remuneration up to EUR 25,000 (excluding TVA) for each Director.

2.2 NATAM Management Company S.A. (the MANCO)

The Remuneration Policy of the MANCO in charge of the management of the SICAV is aimed at ensuring the best possible alignment of the interest of the investors of the SICAV. The Remuneration Policy covers the remuneration of the following persons of the Management Company (together the "Identified Staff"):

- individuals who are members of the governing bodies,
- senior managers,
- risk takers and control functions,
- any employees receiving any type of remuneration that takes them into the same remuneration bracket as senior management and risk takers;

In compliance with current laws and regulations (such as Directive 2011/61/EU, Directive 2014/91/EU, Annex II of the Luxembourg Law 12th July 2012, CSSF Circular 18/698, and 10/437, ESMA Guidelines 2016/411)), the MANCO has adopted for those categories of persons certain remuneration principles that are consistent with and promote sound and effective risk management and do not encourage risk-taking which is inconsistent with the risk profiles, rules or instruments of incorporation of the managed Sub-funds.

The policy is also in line with the business strategy, objectives, values and long-term interests of the managed Sub-funds and is consistent with the principles relating to the protection of investors in the course of activities provided and the avoidance of conflict of interest as a result of the implementation of the said strategy.

The following principles shall apply to remuneration of any type paid by the SICAV, to any amount paid directly by the MANCO itself and to any transfer of shares of the SICAV, made to the benefits of identified categories of staff.

2.2.1 Responsible Person

The remuneration policy is defined by the Board of Directors of the MANCO and validated by the general meeting of shareholders. The Board of the MANCO is responsible for the implementation of the remuneration procedure, the General Manager of the MANCO must control that the procedure is respected and must notify the Board and the Remuneration Committee of the Parent Company (BANCA FINNAT EURAMERICA S.p.A.) for any breach or violation they should be aware during the normal course of their assessment procedure.

2.2.2 Supervision and revision of the Remuneration Policy

Any decision made in relation with the remuneration of the staff will be specifically documented. The implementation of the remuneration policy will be reviewed at least annually by the Internal Auditor and its compliance with Luxembourg legal requirements will also be reassessed regularly by the Compliance function. Any finding or need for update identified by one of these functions will be directly reported to the BoD action. In the implementation and supervision of the remuneration any event, circumstances or indication that may give rise to a potential risk of conflict of interest will be specifically documented. Any change or update of the policy will be submitted to the BoD for approval.

2.2.3 Remuneration components and proportionality principle

The MANCO may pay to the identified staff fixed and variable remuneration according to the procedures set out hereafter. In addition to the negotiated fixed remuneration, the MANCO may offer to its employees various optional advantages (e.g. company car, cell phone, ticket restaurant, car park). In light of its size, the internal organization, the nature, scope and complexity of the activities, the MANCO assesses that proportionality principle may apply to its remuneration framework and in light of the above, the MANCO shall in particular disapply the following rules:

- Set-up of an Internal Remuneration Committee
- The payment of variable remuneration in instruments related mainly to the Funds managed
- Deferral requirements
- Retention periods
- Ex-post incorporation of risk (Malus)

2.2.4 Fixed Remuneration

The members of the Board of the MANCO are entitled to receive a cumulative an annual gross remuneration of Eur 55.000, empowering the Board to allocate this remuneration on the basis of the criteria established by the same board.

The fixed remuneration of the Senior Managers and of the staff is negotiated at the beginning of the relation with the MANCO, based on the individual role, including responsibility, job complexity, performance and local market conditions. Fixed remuneration can be reviewed annually in the contest of an annual performance assessment of the employees.

2.2.5 Variable remuneration

The MANCO may to pay a variable remuneration ("the Bonus") to better gain the manager and employee loyalty, in the long term perspective, sharing with them the corporate goals. According to the directives of the Sole Shareholder, Banca Finnat Euramerica S.p.A, the MANCO has foreseen to the possibility to pay the Bonus to the achievement of certain corporate financial results (determinated as net of the tax and before the calculation of the Bonus) taking into consideration the following elements:

- the payment of the Bonus mainly, but not only, concerns the key persons (considering the direct impact of their personal job performance with the global performance of the company);
- as the business model of the MANCO does not foresee the service of portfolio management on day to day basis (in fact the services provided by the MANCO to its clients only encompass the duties of risk monitoring and oversight on the delegated functions) and does not distribute directly its own funds (the distribution activity in each jurisdiction where the funds are duly notified according to the relevant rules and regulations, is always delegated to local distributors through an appointed Main Distributor), the staff of the MANCO does not include any employees (such as the "investment managers" or "funds sellers") whose personal performances may have been valued in relation to those of the managed funds.

Bonus can be only in the form of cash. In accordance with Par. 8 ESMA Guidelines 2016/411, despite the MANCO being part of a credit institution group ("BFE Group"), the MANCO shall adopt the group remuneration guidelines to the extent that such policies do not conflict with the sectorial guidelines applicable to management companies.

2.2.6 Remuneration of the delegated charged of the Portfolio Management function

The business model adopted by the MANCO foresees the delegation of the portfolio management function. When delegating the portfolio management function, the MANCO will check, during the initial and ongoing due diligence performed on yearly basis, according with the rules set in its Due Diligence Procedure that these delegated entities should be subject to regulatory requirements on remuneration that are equally as effective as those applicable to the MANCO and appropriate contractual arrangements should be put in place in order to ensure that there is no circumvention of the remuneration rules.

3. SUSTAINABLE FINANCE DISCLOSURE REGULATION (SFDR)

In accordance with article 2 of the Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector (SFDR), sustainability risk is defined as an environmental, social or governance event or condition that, if it occurs, could cause an actual or a potential material negative impact on the value of an investment. The impact of environmental, social and governance factors on the value of an investment may vary depending not only on its business activities (e.g. asset type, the sector, size, geographic location and the stage in the life cycle, and liabilities) but

also on the governance and strategy of the company for managing them.

In accordance with article 3 of the Disclosure Regulation, sustainability risks are integrated in the investment decision-making process of the Fund. The risk assessments and investment decisions are based on internal and external research and assessments on sustainability factors and sustainability risks.

At the present the Fund does not consider "principal adverse impacts" of investment decisions on sustainability factors.

Sub-Funds categorised under Art. 8 SFDR

The following Sub-funds are compliant with article 8 of the SFDR: NEW MILLENNIUM - Euro Equities, NEW MILLENNIUM - Global Equities (Eur Hedged), NEW MILLENNIUM - Euro Bonds Short Term, NEW MILLENNIUM - Large Europe Corporate, NEW MILLENNIUM - Balanced World Conservative, NEW MILLENNIUM - Inflation Linked Bond Europe and NEW MILLENNIUM - PIR Bilanciato Sistema Italia.

In accordance with the investment policies and objectives described in the Offering documentation of the Fund, all the above-mentioned Sub-funds aim at promoting environmental or social characteristics, or a combination of those characteristics. The investment manager implements ESG integration in the investment process following two kinds of criteria:

i) the average portfolio ESG rating which is determined in house and at least monthly, on an increasing scale ranging from 0 (less virtuous) to 100 (more virtuous), processing on a weighted basis (excluding cash and derivatives component) the scores assigned by external ESG rating providers, again on a scale from 0 to 100, to each asset held in the portfolio. In order to assign the rating, financial instruments are divided into macro-categories for each of which a "ESG rating", implemented by primary providers, is identified, as represented in the following table.

The remaining Sub-Funds do not fall under article 8 SFDR (promoting sustainability objectives) or article 9 SFDR (sustainable investments): they do not take sustainability criteria into account as part of its investment process, do not promote ESG features and do not haves as objective sustainable investment. The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

4. SECURITIES FINANCING TRANSACTIONS REGULATION

The Securities Financing Transaction Regulation (SFTR) 2015/2365 on transparency of securities financing transactions and of reuse came into force on 12 January 2016 and introduces new disclosure requirements for securities financing transactions and total return swaps.

A securities financing transaction is defined as per Article 3(11) of the SFTR as:

- a repurchase/reverse repurchase agreement,
- securities or commodities lending and securities or commodities borrowing,
- a buy-sell back transaction or sell-buy back transaction, or
- a margin lending transaction.

Total Return Swaps

No collateral has been received for total return swaps.

All the returns of the total return swaps are attributed to the Sub-Funds. The transaction costs are not separately identifiable.

Transactions in total return swaps are bilateral trades.
